UNAUDITED RESULTS OF SUZHOU QINGYUE FOR THE QUARTER ENDED 30 SEPTEMBER 2023

This announcement is made by the Company pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

Suzhou QingYue, an associated company of the Group in which the Group has an equity interest of about 28.08%, announced on 27 October 2023 its unaudited results for the quarter ended 30 September 2023. The loss attributable to the owners of Suzhou QingYue for the quarter ended 30 September 2023 amounted to approximately RMB29.28 million (equivalent to approximately HK\$31.71 million). The loss attributable to the owners of Suzhou QingYue for the nine months ended 30 September 2023 amounted to approximately RMB44.06 million (equivalent to approximately HK\$49.19 million).
